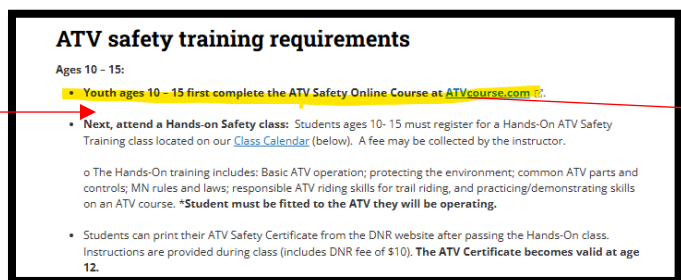

HERE'S WHAT TO DO

1. First, go to <https://www.dnr.state.mn.us/safety/vehicle/atv/index.html> to complete the ONLINE course. Scroll down until you see "ATVcourse.com", and click on it to open. This will take you to a new window and site. Here is where you'll create a login/account and pay for the registration. This is where you'll do your "classroom training". This course will take some time, and you'll have several quizzes. You will **NEED to complete** this online training **BEFORE** you come to field training. Once you complete the course, you'll receive online the voucher.



2. Print off the voucher, this proves that you have completed and passed the online course. You can also email the voucher to CERC Director, Tiffany Dobbs at cerc@littleforkmn.gov as she'll be present that day of field training. This needs to be completed **BEFORE** the meeting on the 24th.

BRING THIS VOUCHER TO THE FIELD DAY.

3. On, Thursday, September 26th, will be the Riding Day/Field Day for ATV Safety.
4. **If you are 16 and older please read:** "Anyone born after July 1, 1987, and who is 16 years or older, must complete the ATV safety online course at ATVcourse.com opens in a new browser tab (and pay all necessary fees online) to meet certification requirements. They are not required to attend the ATV safety hands-on class."

HOW TO PREAPRE

1. Make sure you have your online voucher printed off, this will show proof that you have completed and passed the online course.
2. Dress appropriately, you'll be outside during this field training course.
3. Instructors have the right to remove any one person that is being unsafe and not following directions.

Parents, you are responsible for getting your child to and from the school for the 1st meeting as you'll need to be there as well.

Parents, you are also responsible for getting your child to and from the ATV riding location that will be in the Falls on September 26th. The location will be disclosed at the meeting on September 24th.
